(2) DUTIES & RESPONSIBILITIES OF ANTI-RAGGING COMMITTEE :

- (i) It shall be the duties & responsibilities of the members of the Anti-Ragging Committee/ Squad to be vigilant, oversight and patrolling functions and shall remain mobile, alert and active all times for preventing any form of ragging inside or outside the campus or hostels.
- (ii) The duty of the Anti -Ragging Squad to be called upon to make surprise raids on hostels and other Places vulnerable to incidents and having the potential for ragging and are empowered to inspect such places.
- (iii) The duty of "Anti-Ragging Squad" to conduct an on-the-spot enquiry into any incidents of ragging referred to it by the Head of the Institution or any member of the faculty or any member of the staff or any student or any employee of a service provided or by any other person, as the case may be, and the enquiry report along with recommendation shall be submitted to the Anti-Ragging Committee for action. Provided that the Anti-Ragging Squad shall conduct such inquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witness to place before it the facts, documents and views concerning the incidents of ragging and considerations such other relevant information as may be required.

(3) REVISED PROCEDURE ON ONLINE UNDERTAKING BY STUDENTS & THEIR PARENTS :

In pursuance to the A.I.C.T.E. Letter No. 1-104/AICTE/PGRC/Anti Ragging/2021 dated 22.11.2021 & D.O. F. No. 1-15/2009 (ARC) PT – III dated 12.06.2023, as per revised procedure, it is compulsory for each student & his/her parent/guardian to submit an online undertaking each year at either of the two designated websites, namely www.antiragging.in and www.amanmovement.org.

The revised procedure is as follows :-

- STEP-I :** A student will submit his/her details on the website stated above, read & confirm that he/she and his/her parent/guardian have read & understood the A.I.C.T.E. regulation on curbing the menace of ragging. He/she will confirm & agree that he/she will not engage in ragging in any form.
- STEP-II :** The student will receive an e-mail with his/her registration number and a weblink. The student will forward the link to the e-mail id :aswinikumar05@gmail.com of Mr. Aswini Kumar Pradhan, Lect.in Comp. Sc. & Engg. & Nodal Officer, P.C.I.E.T., Mobile No. : 9861732573. It may be mentioned here that the student will not receive affidavit and he/she is not required to print & sign it as used to be the case earlier.

STEP-III : The Nodal Officer of our institute can click on any forwarded e-mail of the student & update the list of students those who have submitted the anti ragging affidavit/undertaking. The list will be updated every 24 hours.

(4) WHAT CONSTITUTES RAGGING :

Ragging constitutes one or more of any of the following acts.

1. Any conduct by student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student.
2. Indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear to apprehension thereof in any fresher or any other student.
3. Asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student.
4. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher.
5. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
6. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students.
7. Any act of physical abuse including all variants of it sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person.
8. Any act or abuse by spoken words, e-mails, posts, public insults which would also include deriving Perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student.
9. Any act that affects the mental health and self-confidence of fresher or any other student with or without an intention to derive a sadistic pleasure off power authority or superiority by a student over any fresher or any other student.

(5) ACTIONS TO BE TAKEN AGAINST STUDENTS FOR INDULGING AND ABETTING RAGGING IN TECHNICAL INSTITUTIONS :

1. The punishment to be meted out to the persons indulged in ragging has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents.
2. Every single incident of ragging a First Information Report (FIR) must be filed without exception by the institution authorities with the local police authorities.
3. The Anti- Ragging Committee of the institution shall take an appropriate decision with regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging.

4. Depending upon the nature and gravity of the offence as established the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following.
- Cancellation of admission.
 - Suspension from attending classes.
 - Withholding/ withdrawing scholarship/fellowship and other benefits.
 - Debarring from appearing in any test/ examination or other evaluation process.
 - Withholding results.
 - Debarring from representing the institution in any regional, national or international meet, tournament, youth festival etc.
 - Suspension/ expulsion from the hostel.
 - Rustication from the institution for period ranging from 1 to 4 semesters.
 - Expulsion from the institution and consequent debarring from admission to any other institution.
 - Collective punishment when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
